# 1. Minutes of Academic Council Meeting 13th September 2022

**AGREED:** The minutes of the Academic Council Meeting of 13<sup>th</sup> September 2022 were approved.

# 3. Policies for Approval

# 3.1 Graduate Studies Regulations

**NOTED:** The following documents were circulated to all members prior to this meeting:

- Graduate Studies Regulations & Code of Practice Response to SETU Academic Council 13/09/22
- Graduate Studies Code of Practice
- Graduate Studies Regulations

**NOTED:** The Graduate Studies Code of Practice and Regulations were presented at the previous meeting of Academic Council on 13<sup>th</sup> September 2022. Dr. Robin Flynn joined the

meeting and together with Dr. Mark White, VP Research, Innovation and Graduate Studies gave a detailed description of the changes made to the document following input/comments from members at that meeting.

**AGREED**: Following further discussion the Graduate Studies Code of Practice and Graduate Studies Regulations were approved by Academic Council for development to implementation subject to a number of small amendments being made, these amendments include:

- 4.6.3 should be changed to "VP for Research will act as chair of the review panel"
- 6.3 needs to be clearer, suggested text "...grace period normally for 3 months but may be extended to 6 months in exceptional circumstances"

**NOTED**: A working group has been established to look at the implementation of these regulations, they will also look at issues raised by members including operational matters such as registration processes and start dates.

**NOTED:** Report on student completion periods including outcome of the examination process to be brought to a future meeting of Academic Council

# 3.2 Authorship Policy

**NOTED:** Draft Authorship Policy was circulated to all members prior to this meeting. The scope of this policy is to outline the guiding principles on authorship of publications arising from research activities, including collaborative work of SETU staff, researchers and students. This document was approved by the Research Committee at their meeting on 27<sup>th</sup> September.

**AGREED:** The Authorship Policy was approved by Academic Council

### 3.3 Student Charter

**NOTED:** Draft Student Charter was circulated to all members prior to this meeting. The purpose of this Student Charter is to articulate a formal statement of the commitment that the University makes to our learners and outlines their part in the community that forms the overall environment that enables new knowledge creation and social change, by ensuring meaningful involvement and input of students to the strategic and operational development of the University. The Charter is designed to set out the commitment to learners in creating a mutually supportive and values driven environment. This Charter is built upon a philosophy of learner engagement.

**AGREED:** Following discussion the Student Charter was approved by Academic Council subject to a small number of amendments which include:

- Page 3, final point under "SETU will Provide an internationally recognised qualification that is recognised within the national framework of qualifications and is valued for the quality that enables career progression" should read "...and is valued for the quality that enables self-development/career progression"
- Page 4, point number 5 under "SETU will" should include a caveat

**NOTED**: Mechanisms for publication to be explored.
