1. Minutes of Academic Council Meeting 15th November 2022

AGREED: The minutes of the Academic Council Meeting of 15th November 2022 were approved.

2. Matters Arising

NOTED: Following discussion on Strategic Plan Update at the previous meeting of Academic Council it was agreed that a number of reports be brought to a future meeting of Academic Council, one such report was on CAO Performance and members suggested that a similar report on all students who come to SETU and how they progress should be brought before Council. D. O'Byrne advised members there is a wide range and variety of data available but we need to identify the ones relevant to Academic Council and perhaps produce a "dashboard" for these.

SRS data could form basis of this and the Strategic Planning Offices should be invited to show their analysis of the integrated SRS data annually.

3. Policies for Approval

NOTED: Dr. Chris O'Riordan joined the meeting for these items.

3.1 SETU Quality Framework

NOTED: Document "South East Technological University (SETU) Quality Framework" was circulated to all members prior to this meeting. This document sets out the SETU Quality Framework. It represents an overarching Quality Framework that encompasses the whole of SETU and which covers all activities of the university across all units, areas and functions. Under this Quality Framework exist three core elements – Academic Reviews, Service Reviews and Regulation and Policy. Dr. O'Riordan commended the huge amount of groundwork by Dr. Siobhan Ryan, Dr. Paul O'Leary and their Working Group on this document and also advised that the document had been before the Executive Management Team (EMT) last week and feedback from that meeting and today's meeting of Academic Council will be incorporated into the document.

NOTED: Dr. Chris O'Riordan gave a presentation on the policy which included:

- The Underpinning philosophy
- Purpose of the Quality Framework
- SETU Approach to QA and QE
- Principles of the SETU Quality Framework

AGREED: While the Policy articulates quality as the delivery of the Quality Framework in practice, it might be beneficial to include a broader definition on quality based on International and National practices. A small group of members should look at international definitions of Quality, this group to include Brian Casey, John Maher and Chris O'Riordan. The document "South East Technological University (SETU) Quality Framework" was approved as a working document.

3.2 SETU English Language Requirements

NOTED: Document "SETU English Language Requirements – Discussion Paper for Academic Quality and Regulation Committee" was circulated to all members prior to this meeting. This document was discussed by the Academic Quality and Regulation Committee at its meeting on 25th November 2022. The recommendation of the Committee was to integrate SETU English Language Requirements and that requirements should be set at a point where no student is displaced and that it should be set at a minimum collective level.

NOTED: There was concern amongst members regarding Duolingo as an entry qualification. Members expressed a desire for wider discussion on application of English Language Requirements.

AGREED: Not to accept the recommendation of the Academic Quality and Regulation Committee to approve a unified approach on the English Language Requirements. Academic Quality and Regulation Committee to reconsider.

3.3 Student Academic Misconduct Policy and Disciplinary Procedure for SETU

NOTED: Document "Student Academic Misconduct Policy and Disciplinary Procedure for SETU" was circulated to all members prior to this meeting. This policy provides the means by which allegations of academic misconduct by any student of SETU may be made, investigated and addressed.

NOTED: Dr. Chris O'Riordan gave a presentation on the policy and began by acknowledging the great work of the Working Group set up to develop this policy. Dr. O'Riordan advised members that the document has been sent to staff unions for consultation, it has also been presented to the Executive Management Team and was sent to the Presidents and Education Officers of both Students Unions.

NOTED: Members welcomed the document but had some concerns over the retention of data and it was suggested the Data Protection Office should be asked to review the document to ensure compliance. Members also suggested that appendix 1 & 2 should be updated to include AI tools and that the High Level Workflow Diagram of Student Academic Misconduct included in the presentation be included in the policy document.

AGREED: The Student Academic Misconduct Policy and Disciplinary Procedure for SETU was approved.

NOTED: Dr. Chris O'Riordan left the meeting.
